

## REIMBURSEMENT OF EXPENSES FOR AIDS/DEVICES DIRECT (documentation for employees of Bodies, Associations and Organisations)

As of 1st June 2021, within the limits of the ceiling and sub-ceilings shown below, the Sanedil Fund reimburses the member directly, until the allocated budget is exhausted, for expenses incurred for the purchase or rental of the following medical aids and devices:

- Wheelchair
- · Orthopedic insoles
- Crutches, sticks, tripods, quadripods, and various walkers
- Orthopedic bust
- Orthopedic corset
- · Orthopedic braces/orthoses
- Abdominal container
- Orthopedic footwear

In order to benefit from the service, the member must submit the appropriate completed form to the cashier, attaching the medical prescription from the specialist detailing the diagnosis or presumed or ascertained pathology that made the service necessary, and the invoice/receipt of expenditure issued by the supplier that proves the purchase, showing a date later than the indicated dates.

Therefore, the Fund shall pay the benefit directly to the requesting member, after verifying that the Employer has correctly paid their Sanedil contributions. The ceiling and the sub-ceilings are shared by the family unit; they benefit the member, the spouse who is registered as fiscally dependent on the member, and minor children who are fiscally dependent on the member.
