



## **GUIDE TO SELF-MANAGED BENEFITS**

### **SANEDIL FUND**

Supplementary Health Fund for Construction Workers

## CORRECTIVE LENSES AND/OR FRAME

The Sanedil Fund will reimburse the member directly, within the limits of the maximum amount provided for and until the allocated budget is exhausted, for any expenses incurred for the purchase of:

- Prescription corrective lenses for glasses
- Corrective contact lenses
- Eyeglass frames that cannot be ascribed to aesthetic purposes

In order to benefit from the guarantee, the member must present the appropriate completed form to the Fund, attaching the relevant invoice/receipt.

In the case of reimbursement for the purchase of corrective prescription lenses for glasses and corrective contact lenses, it is necessary to present the prescription from the ophthalmologist or the certification from the optometrist attesting to the vision correction/defect. No more than 12 months must have passed between the date of the medical prescription or the certification by the optometrist, **which cannot be repeated for more than a single request**, and the date of issue of the expense document.

In the case of a refund for the purchase of the frame only, the request must always be supported by documentary evidence showing the adaptation of the corrective lenses already in use to the new frame.

Therefore, after verifying that the company's contributions are in order, the Fund will act as an intermediary for the reimbursement requests, which will be paid by the Fund directly to the requesting member. This benefit has a shared maximum per family unit and the member, their financially dependent spouse, resulting from the family status and their financially dependent children can benefit from it, even if they do not live together.

## AIDS/DEVICES

The Sanedil Fund will reimburse the member directly, within the limits of the maximum amount provided for, until the allocated budget is exhausted, for the expenses incurred for the purchase or rental of the following medical aids and devices:

- Orthopaedic busts/orthopaedic corsets
- Orthopaedic footwear and orthopaedic insoles
- Abdominal supports
- Wheelchairs
- Crutches, canes, tripods, quadripods and various walkers
- Braces
- Orthoses

In order to benefit from the service, the member must present the appropriate completed form to the Fund employee, attaching the medical prescription from the specialist in the field, with the diagnostic question or presumed or confirmed illness that made the service necessary and the relevant invoice/receipt issued by the supplier which proves the purchase.

Therefore, after verifying that the company's contributions are in order, the Fund will act as an intermediary for the requests for reimbursement, which will be paid by the Fund directly to the requesting member. The maximum amount is shared with the family unit and the member, their financially dependent spouse, resulting from the family status and their financially dependent children, even if they do not live together, can benefit from it.

## PHYSIOTHERAPEUTIC REHABILITATION TREATMENTS

The Sanedil Fund provides direct reimbursement to the enrollee, up to the maximum amount provided and until the allocated budget is exhausted, for expenses incurred for rehabilitative physiotherapy treatments in the case of diseases other than those covered by the UniSalute Health Plan.

Treatments can be performed in facilities and by private professionals or through the National Health Service (NHS). There is no overdraft or deductible. No more than 12 months must have elapsed between the date of the prescription and the date the expense document is issued.

In order to qualify for the benefit, the enrollee must submit the appropriate completed form to the Fund's office, enclosing the medical prescription and the receipted invoice/relevant slip issued by medical or paramedical personnel licensed in rehabilitation therapy, the title of which must be stated on the expense document.

The Fund, therefore, upon verification of the company's contributory regularity, will act as a conduit for reimbursement requests, which will be settled by the Fund directly to the requesting member.

This benefit is only available to enrolled workers and therefore the nuclear family is excluded.
